## Terms and Parties

By virtue of payment of the stipulated premium of this policy and based on the representations and warranties contained in this application, this company undertakes to indemnify [illegible] hereinafter called the policy holder, residing in [illegible] up to an amount not exceeding the limits indicated by losses or damages incurred in the event of the risks, which as they are explained in this policy can be sustained or caused by the motor vehicle or vehicles described in the policy, while they are within the territory of the Dominican Republic and as long as such losses or damages have been suffered by the policy holder due to accidents that occur within the period between 4:00 pm on 01/03/2017 and 4:00 pm on 01/03/2018

## Representations and Warranties

The details established in these conditions are the representations and warranties provided by the policy holder who guarantees the accuracy and truthfulness of these, and based on these the company renews the policy, limiting itself to applying the premiums that correspond to said representations.

The Auto Excess coverage only covers in excess of the limit prescribed in the primary insurance listed in the particular conditions of the insured vehicle, only concerning the covered risks under said primary insurance.

The appointed limit for each vehicle functions as a Combined Single Limit per event and year policy for the specified coverages in the particular conditions.
